

- The law forbids discrimination when it comes to any aspect of employment, including hiring, firing, pay, job assignments, promotions, layoff, training, fringe benefits, and any other term or condition of employment.
- can be illegal if it has a negative impact on the employment of people of a particular race or color and is not job-related and necessary to the operation of the business
- The EEO laws prohibit punishing job applicants or employees for asserting their rights to be free from employment discrimination including harassment.

Con:


- Any state were permitted to ban abortion under state and federal law
